## Terms:

MSC requires a **non-refundable deposit** of \$1,250 at the time of contract. Date(s) will not be secured until a deposit has been received. Final notification of participant count is due one week in advance of the event and a 90% guarantee of that number is required. The balance will be due and payable within 15 days of invoicing. An overtime use charge of \$200 per hour will be assessed for events extending beyond the originally scheduled and agreed upon timeframe. All taxable items are subject to 6.0% sales tax unless proof of tax exemption is provided prior to event date.

## Cancellation Policy:

In the event that the CLIENT should cancel this contract outside 72 hours of signing the contract, CLIENT agrees that such cancellation will result in the forfeiture of their deposit. In the event that MSC cancels the contract at any time, then the CLIENT'S deposit will be fully refunded. If the CLIENT requests to change the date of their event, MSC at its sole discretion can approve such change. If MSC cannot accommodate CLIENT's change request, CLIENT then must comply with the terms and conditions of this contract. If MSC can accommodate the change, a revised contract will be executed.

## Inclement Weather:

The event will go on in rain or inclement weather. MSC will suspend shooting if lightning is sighted and continue the event thereafter if able. If the event is totally rained out, MSC will reschedule to another date subject to availability. The CLIENT will be responsible for any charges incurred by MSC on behalf of the event regardless of weather. These items can include but are not limited to: golf cart rental, food and beverage orders, and any extra labor or venue preparation. All other services will be transferred to the rescheduled date.

**A non-refundable deposit of \$1,250 is required at the time of contract acceptance to secure event date.**
